uNiel Kenaan (CIANAIN) unomsuka wase Ireland kodwa wazalelwwa esiqhingini sase Rhodes eMelika.


uNeil Kenaan ungu somabhzinisi womhlaba olwisene ne Khabhal (Cabal) eminyakeni eyisikhombisa eyedlule, wabekezelwa waze waba umlweli womhlaba wonke elwela amalungelo abantu.

ama” Global Collateral Accounts (GCA)”

-ubani owayazi n gama GCA ngaphambi kweminyaka eyisishiyagalombili edlule. Bancane kakhulu, noma ngabe wawubuze u Neil ngalesosikhathi, ngabe wathi akazi lutho ngawo nangobumqoka kwavo. Wangena kuwo ecabanga ukuthi kwakuyinto eyibhizinisi elejwayelekile njengamanye amabhizinisi. uNeil wafunda ngokushesha ukuthi lento inkulu kakhulu, nendlela yokusiza uluntu yayiphambi kwakhe.



Esikhathini esiyiminyaka eyisikhombisa ekusindiseni i GCA eyisindisela abafaki bezimali, uNeil kade ethintana nabantu abasemqoka emhlabeni (abaziwa ngokunyakazisa izinto) kusuka kosomabhizinisi, abaphethe amabhange, abahwebi, amakhanda emibuso, nondlunkulu, naBadala baseMpumalanga.

Bonke bayamazi uNeil futhi-ke kulomdlalo omkhulu wezimali, uNeil useke wahlangabezana nezigebengu ezinkulu ze Khabhal ezinhlobonhlobo.

Ngolwazi lwakhe olukhulu lwezamabhizinisi kuhlangene nobuyena njengomdlali nomulwi, uNeil selokhu kwathi nhlo ulwela abantukazana ukuze nabo baze babe ngabantu.

Umlando wakhe ongajwayelekile umenze awufanele umsebenzi wakhe wokusindisa ama Global Collateral Accounts ewasindisela abafaki zimali (depositors)

okuzokwenza abantu bakhululeke ebugqilini be Khabhal.

Ngomboniso uNeil ukhombise ngokusobala ukuthi umuntu angenzani uma echukuluzwa ukuthatha ubu ngqoshishilizi bomhlaba yilabo abaphehla ukuqedu uluntu lomhlaba.

1.02 Isingeniso Esiwumlando. Landela Indlela Yezitini Eziphuzi.

Amukho umuntu okufanele avalwe amehlo empilweni yakhe. Amukho umuntu okufanele afundiswe ebephathwa njengesilwane esingenangqondo esenza noma yini esiyitshelwayo njengemvu.

Umsebenzi weqembu lika Kenaan wukuvikela umcebo womndeni wakwa Dragon.

Ngokuka Neil, uma ama Global Collateral Accounts eselungile, uyobe esekwazi ukubhekana nezinto ezibhalwe esivumelaneni sase Bretton Woods sika 1944, esiwubuqhophololo.

Lesisivumelwano esenziwa eNtshonalanga sasi wubusela obukhulu emhlabeni wonke kodwa ikakhulukazi kumazwe angachemile (NON-ALIGNED COUNTRIES) hhayi kuphela lesi sika 1944 kodwa nesesibili sika 1995. Okukhulukazi ukuthi, ubusela bokugcina benzeka ngaphambi kokuba u inki wome esivumelaneni (epenini).

Umlando wezehlakalo ezikhonjisa lapha usiza wena ukuqonda ukuxhumana phakathi kuka president Sukarno (M1+NAM) no president Kennedy. Yini eyayenza isivumelwano sabo sase Green Hilton Memorial sibaluleke kangaka eluntwini?

Abanye bayazi ngegolide elaliwumcebo oyi Colleteral elalibolekwe uKennedy, elalizomvumela ukuba asebenzise lomcebo ukunika abantu baseMelika imali yabo esekelwe yigolide “Treasury Notes” eyayizovumela abantu base Melika ukuthi bahlukane ne US Corporation ne Federal Reserve (lokhu okuphethwe yizigebengu zakwamanye amazwe) besekuphinde kuhlakaze izigebengu eziyi CIA .

Uma uKennedy no Sukarno babephumelele, iMelika ngabe yakhululeka ezikweletini ezbophanayo naku Hulumeni oyimfihlo. Lokhu kwakuzokhulula nezizwe ze G20 eziphethwe yimithetho yama central banks azo.

Into elandelayo uKennedy no Sukarno ababezoyenza kwakuzoba ukucisha isivumelwano se Bretton Woods esingacabangelani (esisiza kuphela amazwe awu 44) baphinde babhale isivumelwano esisha esifaka, ngalesosikhathi, amanye amazwe angu 120 namazwe angachemile (NON-ALIGNED), lokho okwakuyowanika ilungelo lama Global Colleteral Accounts abo. Lokhu akuzange kuvunyelwe ngoba iNtshonalanga kwakuyiyona kuphela eyayinelungelo lama GCA.

Lama GCA ekuqaleni ayenzelwe ukusiza emisebenzini yoluntu nokushintsha izwe libe ngcono. Kodwa kade esetshenziselwa ukufeza ubuqhophololo esetshenziswa amabhange anobugebengu.

2.00 Ukuqhozomela KweLondon Nenhlangano YaseMelika/USA FEDERAL RESERVE CARTEL



Umlando omubi emva kwamaGlobal Collateral Accounts mukhulu futhi unxakanxaka, ufinyelela eminyakeni ewu 250 edlule.

Ukupathwa komhlaba upathwa ngabaphethe amabhange noHulumeni abambalwa okwenzeka manje kusuka emuva ekuqhozomeleni komndeni wakwa Rothschild amabhange omhlaba jikelele ngasekuqaleni kweminyaka yo 1800 (early 19 century).

Umhlahlandlela omude wabaphezulu abacebile bamabhange nabomndeni begazi lobukhosи wawulula “Tholani ukupathha igolide lomhlaba ukuze nihlale niphethe ngokungamela imali yomhlaba nesibambiso sayo(collateral)” Igolide nesikweletu iyona ngqikithi yalendaba.

2.01 Ukuzingela Amadada Okwazala iFederal Reserve

Umhlangano wase Jekyll Island wakwa 1910 wanikeza indawo ecezile efihlekile yokuxoxa ngezimfihlo zemiqondo yamabhange, kwenza ukuba kuvumbuke icebo elagcina seliyi Federal Reserve Banking System.

I Federal Reserve System igama elanikezwa amabhange awu 12 angama Central Banks ekuyiwona aphethe amabhange aseMelika. Futhi aqinisekisa ukuthi abafaki zimali abawongxowankulu abalahlekelwa yizimali zabo uma kukhona imikhonyovu emabhange asemthethweni.

Lokhu kwakuyinkinga enkulu enhlanganweni yama Rothschild-Rockerfeller-Morgan .





Ngo 1912 i USA okuqala yayiyi Trust Management Organisation (US Corporation) yathengwa yisigungu samabhange esasenza ibhizinisi ngegama i Federal Reserve.

Ngo 1913 basebengenise i“Federal Reserve Act” ngokuhamba ngendlela yomthetho wamathenda. Baqala bejunge ngamabomu ukwehlisa i dollar lase Melika ukuze bawise inkampani eyayindala eyayikade yenza ibhizinisi njenge United States of America, Inc.



I Federal Reserve yabucala, ekhipha imali eyiphepha(i Fiat Money), eyama US Federal Reserve Notes, iphethwe futhi ilawulwa yi Crown Temple esedolobheni lase London, e Switzerland, ikhaya lomsuka womthetho ophethe nolawula i United Nations (UN) , International monetary Fund, World Trade Organization, Okubalulekile ne Bank Of International Settlements.

I Bank Of International Settlements e Basel eSwitzerland lilawula wonke ama central banks ezizwe ze G7 “ Lowo olawula igolide ubusa umhlaba.”

Umthetho (judiciary) was USA ulawulwa umthetho wase Crown Temple esedolobheni elizimele e London.

2.04 Umthetho ka 1921. Esivumelwano sezizwe: Ikhomishani yegolide


Umthetho ka1921- isivumelwane sezizwe (trilateral, trillenium, tripartite gold commission: ngo 1921, umbusi (Emperor) u Herohito wase Japan wandizela eLondon ukuyohlangana nenkosi uLloyd George V wase Britain, u president Warren Harding wase USA nomphathi wase France George Clemenceau (bonke bangama Masons- abakhi ngamatshe nangama blocks) injongo kwakuwukuphehla nokukhokhela impi yomhlaba yesibili. iFederal Reserve yayizokhokhela i NAZI yama Jalimani (German) ize iphele impi.



amaJapan , ngokwesivumelwano sokuqala esasensiwe u Herohito esivumelwaneni sika 1921 sezizwe yahambisa eliningi laleligolide e Indonesia (eyayiphethwe ama Dutch) nase Philippines (eyayiphethwe iMelika) emigedeni eyimfihlo eminingi yayo eyayakhiwe ngamatJapan ngeminyaka yo 1924 kuya ku 1945.

2.05 Ukuwa kwe stock market sase New York ngo 1929

Ngo 1929 abanini bangasese be US FEDERAL RESERVE (Rothschild agents-JP Morgan, CT Bank ne Chase Manhattan Bank) basebenzisa amandla abo asezimaketheni ukwenza izimakethe zinonophale balutha amabhange amancane nabatshali zimali bangasese ukuba bafake izimali ezinkulu.






3.00 Isivumelwano saseKuomintang nama Colleteral Accounts



3.01 Isivumelwano sase USA ne Republic yase China sokuqashiselana

Entwasabusika ka 1911 kwaba nesimo esasenziwe esenza abantu bavukele umbuso. Lokho kuvukela ummbuso kwabizwa nge Xinhai Chinese Revolution of 1911. Babelwa nombusi u Qing(noma u Manchu) nenzalo yakhe. Izifundazwe zaqala ukuzinikela ekulandeleni abaphehli bodlame enhlosweni yabo yokwenza i Republic yase China, bavale indlela yokubuswa amakhosi.


Udokotela Sun wayese Melika ehamba ecela izimali ngesikhathi kuqala loludlame. Washesha waya e London nase Paris enzela ukuthi lamazwe angabasizi ngezimali laba bombuso ka Qing (nangosizo lwezempi). Behlangene bakhetha u dokotela Sun njengopresident we Republic yase China eyayiyintsha.



Umhlaba wonke awukhombisanga kuthuka kangako. Iziwe zangaphandle ezazifake izimali eChina azichemanga ngesikhathi se nxushunxushu. Noma amaphaphu ayephezulu zifisa ukuvikela ilungelo lesivumelwano ababesithole ku Qing ngesikhathi sempi yokuqala neyesibili ye Opium (1839-1842 no 1856-1860).

Imelika yaqhube ka ukusekela lomsebenzi we Republic, kwathi ngo 1913, iMelika yaba phakathi kwamazwe aqala ubudlelwano nale Republic. I Brithani ne Japan neRassia basheshe balandela.

Phakathi kuka 1927 no 1938, okwakungumphumela wesendlalelo esenzeka phakathi kuka T.V Soong (ungqongqoshe wezimali e China)no Henry Morgenthau (owayengunobhala womnyango wezimali eMelika), iMelika yathenga 50 million wama ounce e siliva yaqasha inqwaba yegolide kuholumeni wase China owayaziwa nge Kuomitang phansi kobuholi buka Chiang Kai-Shek ngo 1928.



Ngalesikhathi iChina yayigcwele amasosha ase Japan. amaChina ayesaba ukwembozelwa amaJapan .

Phansi kwesivumelwano esenziwa yi China ne Melika ngasese Kwakhishwa izitifiketi zikhishelwa lomnotho owulethwe yiChina. Lezizitifiketi kwaqala amanothi ngo 1928 kwasekuba ama Federal Reserve notes ngo 1934 kwaba yisona sisekelo sezimali ze Kuomitang futhi yikona okwenza uhulumeni wamashayina eTaiwan uqhubeke ngokwezimali.

3.02 Umthetho Wokuphepha Nokuntshontshwa kweGolide eMelika ka 1934

Ngonyaka ka 1934 kwenziwa umthetho wokuphepha omusha eMelika kanye nomthetho wegolide eligciniwe, owadinga ukuthi lonke igolide eliyizixebeledu (Bullion) nelingama coin linikezelwe kwi Fed Reserve okuyinkampani yabucala eyayibekwe ngokungekho emthethweni ukuba isebenze njenge Central Bank enku yaseMelika bese likhipha imali engamaphepha yaseMelika.



Igolide langaphakathi lathengwa. Igolide langaphandle elaliphethwe abaphethe umnotho bangaphakathi(Treasury) nalo lanikezelwa noma labolekwa ama Feds okwaholela ekukhishweni kwezincwadi (notes) yiFed. Lama FRN's akaze akhokhelwe, nenzalo yawo yahlangabezana nokuphinde kukhishwe amabonds athize ka 1968 ka Kennedy.

Amaningi ama FRN's asala e China yamakhomanisi ngesikhathi i Kuomitang ngaphansi kuka Chiang Kai-Shek kufaneleke ibalekele e Taiwan.

ama FRN's ayenenani elihle ngoba ayemele igolide neminye imicebo embiwa phansi okwakuthengwe noma kwabolekwa uhulumeni wase Melika. i Kuomitang yabeka ababheki baleligolide neziqiniseko ezazinikezwe i Melika abagcina sebaziwa ngokuteketisa njenge Dragon Family.

4.00 Inhlango yaseMpumalanga (Asia) eyaziwa nge Dragon Family

4.01 Ngo 1934 baziwa njenge Dragon Family.

iDragon Family empeleni iyinhlangano esebezena phakathi kweminden emidala eChina nase Taiwan ngaphezu kwenhlukano yembusazwe wamazwe amabili amaChina azimele.

Ama China ayamangalisa ngokuthi izibopho zomndeni nemisebenzi kungaphezulu kwezimo zombusazwe, okungenzeka ziqhubeke izizukulwane, kodwa azithathwa njengezisemqoka ekuhambeni kwesikhathi emashayineni amaningi. Lapho kubambelele umnotho wezizwe eziningi.

iDragon Family ayiziggamisi ukuba ibukwe noma yaziwe abantu kodwa isebezelu uluntu lomhlaba futhi bahlala bethintana besebezisana namazinga aphezulu ezinhlangano zezimali zomhlaba, nekomidi lika 300 futhi ikakhulukazi ne Federal Reserve System.

Uhulumeni wase Melika waboleka isizumbulu somnotho we Collateral ku Dragon Family eminyakeni eminingi edlule. Ingqikithi yalomnotho owabolekwayo isuka kwi Dragon Family iya kuhulumeni waseMelika kwakuyigolide ne siliva. Ngakhoke uhulumeni waseMelika wakwazi ukukhipha izizumbulu zama dollar okuyimali (FRN's) ngendlela edlula ku FRB(ibhange le federal reserve).

Ngesikhathi sobudlelwano babo eminyakeni engengaphezulu kwekhulu eyedlule umndeni wakwa Dragon uqokelele umcebo omkhulu (basakweletwa ama trillion ngama trillion enzalo), lomcebo uyimali yamaphepha enhlobonhlobo, amabond nezitifiketi eziyizibophezelo ze Federal Reserve System. Izimali zenziwa zahambisana negolide, i IMF yanikwa igunya lokungelela lapho sekukhona inkinga ekukhokhelaneni nasezingeni loku khokhelana .



Eqinisweni ngo 1944 i Britain, France, ne Melika zanikwa iminyaka engamashumi ayisihlanu yokuphatha zengamele izimali zomhlaba .

Isivumelwano kwakufanele sikhulise futhi silungise kabusha umhlaba, kodwa ngesikhathi kubulawa u Roosevelt ngo shevu igolide lomhlaba lakhishwa ezimakethe, langcoliswa noma lafihlwa emigedeni.





Uumphumela kwaba yisibhicongo, abaningi abalinganisayo bathi kwafinyelela kubantu abayisigidi sabalandeli baka Sukarno, abasebenzi, abantu abasemazingeni aphansi, abafundi, izishoshovu zommbangazwe nabantu bokuzalwa e China, futhi amashumi ezinkulungwane ngaphezulu baboshwa emajele nasezinkambweni zokuhlukunyezwa(concentration camps) ngaphandle kokuzilwela okubonakalayo.



General Suharto kwesobunxele




Suharto no Nixon

Ngo January 1967 basebesuse bonke abalandeli baka Sukarno abaqavile kwezempi. Ngomhlaka 27 March 1968, uSuharto waba ngu president wase Indonesia.

Akakhethwanga ngabantu kodwa wabekwa yi phalamende elalikhethwe nguyenu u Suharto, eminyakeni yokuqala kweyisihlanu yakhe yokubusa.

Lokhu kugumbuqela umbuso kuka 1965 okwakuphehlwe yi CIA. Kwakungo Kennedy no Sukarno ukuvumelana kwabo ukusebenza ndawonye ukubulala i CIA kanye ne Federal Reserve Bank. Kwakuyindlela yokubuyisela ngaphezu kokuba kwakufanele. Lokhu kugumbuqela umbuso kwakubizwa nge (Rebellious Revolution) basola amakhomanisi, kodwa ngokweqiniso iNtshonalanga iyona eyaqala loludlambedlu njengoba kuhlale kwenzeka ngokujayelekile kunoma iyiphi indawo yomhlaba engalaleli amazwe ayizikhondlakhondla.



Imibhalo iyakhombisa ukuthi ngawowonke u 1965 nasekuqaleni ka 1966 abasemagunyen baseMelika nabase Australia babebika ngokuvumelana (bebika amanga) bebikela ohulumeni babo ukuthi amabutho nama Muslim babesebenzisana ukuthi kubulawe 1500 babalandeli baka Sukarno ngosuku, ngesinye isikhathi babukise ngamakhanda abo echonywe ezintini.

Ngo 1966 upresident Marcos wase Philippines waqokwa ngokungemthetho eqokwa yiNtshonalanga ukuthi athathe isikhundla sika M1 kuze kube ngu 1986.

Emva kwalokho isimo sabuyela emuva ezizweni ezintathu okuyizona ezaziphethe ziphinde zidale lama Account selokhu kwasukela ngempi yesibili yomhlaba. iMelika, iNgilabde kanye ne France okuyiwona mazwe achitha lenqubo ngokungemthetho. Baphinda futhi bachitha nesivumelwano se Bretton Woods ngo 1955.





U.S. District Court Lawsuit involving the Dragon Family



The U.S. District Court lawsuit has aroused considerable controversy over its authenticity and the ownership of the \$145.5 billion in Federal Reserve notes, bonds and other financial instruments. The lawsuit was filed by William Mulligan Jr and Justin Gardner from Bleakley Platt and Schmidt, a reputable New York law firm.

The principal plaintiff in the lawsuit, Neil Keenan, claims to have been defrauded by a number of official government agencies and political figures including a little known organization called the Office of International Treasury Control (OITC), and its principal officers Dr Ray Dam (President) and David Sale (Deputy Chief of the Council for Cabinet of OITC).

On the other hand, Sale claims that Keenan and his accomplices fraudulently gained possession of the bonds from the OITC. Importantly, neither of the two parties contesting ownership of the bonds dispute their validity.





* The Origins of the Keenan surname:

Gaelic for “Cianain” and originates from the ancient pre-10th century in Ireland.

The Gaelic name O’ Cianain meaning:

“The descendant of the faithful one”

The Cianain’s were found mainly in the Ulster northern counties of Fermanah and Monaghan during the ancient pre 10th century.

It may not have been entirely coincidence that the clan was famous throughout the Medieval Period for producing both high-ranking members of the church, and early historians, in several cases the same thing.

The first recorded scribe was Adam O’ Cianain, who was also the canon of Lisgool in Fermanagh. He is mentioned in the annals known as the “Four Masters” as being the historian to the famous Maguires of County Fermanagh in Ulster.
